**Individual Membership:** The indicated person applying for membership will be listed as single owner on any animal certificates.

**Ranch Membership:** Multiple individuals – for a family or ranch. Ranch membership allows any of the named individuals to conduct business for this membership. Ownership (as set by default) will be listed on registration papers based upon the first line of this application. (unless specified on a case by case basis with the office) In addition, any combination of individuals can be listed as owning any specific animal under this membership - this choice is specified on the animal registration form.

**Junior Membership:** A junior is defined as being not older than 18 on January 1<sup>st</sup> of a current year. A junior's parent or guardian must be named as a contact. Note: only dues-current juniors can show in Intl. Boer Goat Assn.-sanctioned "Junior" shows, and can only show animals registered in a Junior name and membership number. Juniors may be part of Ranch memberships; however, they may not use those memberships for Junior showing purposes.
